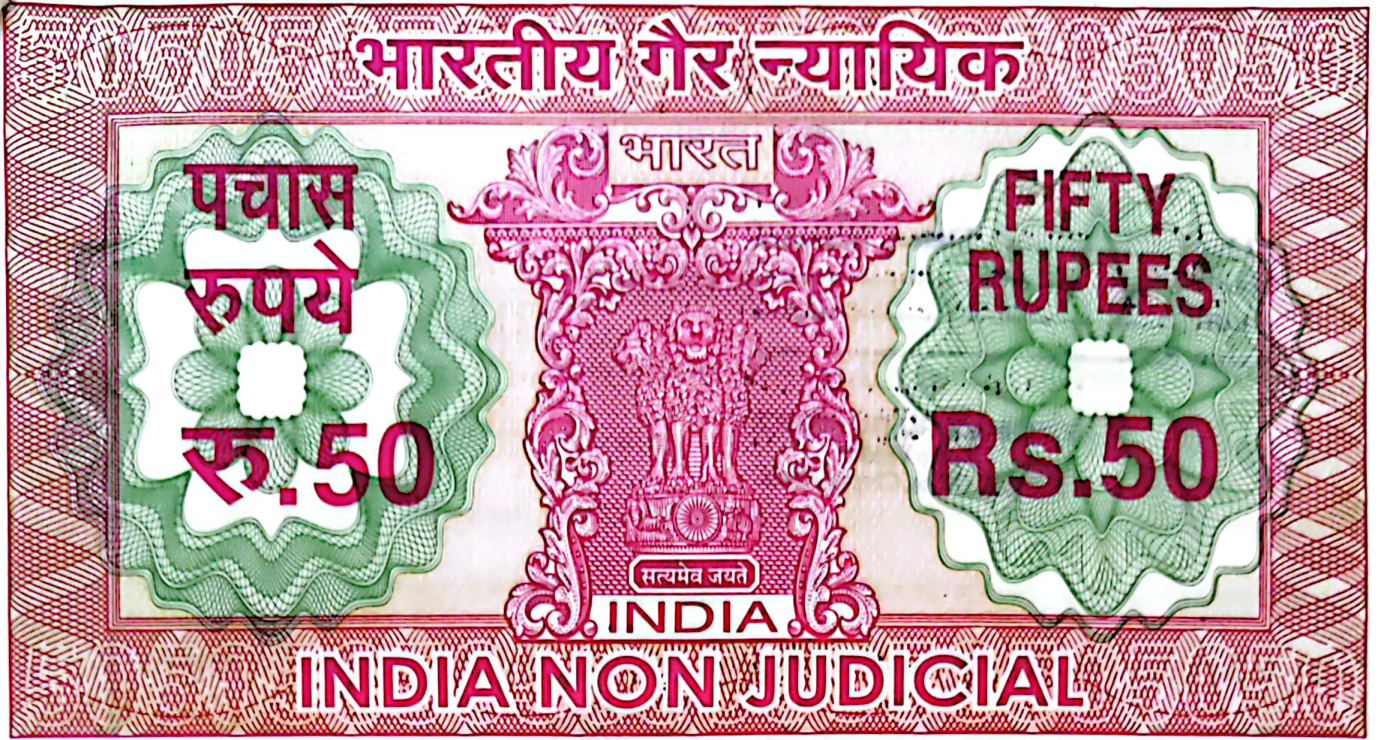

NOW THIS INDENTURE WITNESSES AS FOLLOWS:

(1) SETTLEMENT:

In order to effectuate and said objects of creating and established a public charitable trust, the settler has delivered to made over to the Trustees a sum of Rs. 30,000/- (Rupees Thirty thousand) only with intent to part with all the right , title and inter claim therein and vest the same in the Trustees to have and to hold the same and the investment or investments for the time being represent the Trust estate together with all addition and accretions hereto and all accumulated income thereof at all other property or properties that may be acquired out of the same otherwise may thereafter be subject to the (hereinafter referred as "THE TRUST FUND") for the charitable objects and purposes and uses herein after expressed with the power and on the terms and conditions here contained of and concerning the same.

(2) NAME:

That the name of the Trust shall be " EDUCATIONAL RESEARCH COUNCIL".

(3) ADDRESS :

The office of the Trust shall be situated at: Village & P.O. Tilakpur, P.S. Chapra, Dist. Nadia, West Bengal PIN- 741164 which may be removed from time to time to such other place or places as the trustees may deemed fit and proper at their discretions.

(4) THE OBJECTS OF THE TRUST SHALL BE :

- I. To help in social justice and eradication of illiteracy.
- II. To provided quality education in any field to the aspiring students.
- III. The Trust will established Technical Institutions,(i.e. Industrial Training Institutions, Diploma in Technologies, Degree in Technologies) Management, Pharmacy, Nursing , Medical, Mass Communication and Nursery for the benefit of poor Rural peoples.
- IV. To set up Medical /Dispensaries in Homoeopathy, Ayurvedic, Allopathic systems for the poor in rural and urban slum areas.
- V. To establish a Residential Science College & Law College for the betterment of local rural students.
- VI. To establish B.Ed. , D.Ed. & M.Ed. College to make ideal Teacher through proper and qualitative training with the help of expert educationists and necessary permission of appropriate authorities.
- VII. To provide knowledge to the people to eradicate superstitions from the society and make people live up to the mark.
- VIII. To act to bring awareness in the society to alleviate social justice among the people.
- IX. To help in bringing awareness about health safeguards and facilities for the physically and mentally impaired.
- X. The Trust will take up programs by organizing seminar, workshops and promoting training cum production centers among rural mass and migrant labors and forming Self-Help Groups and linking them with banks and other financial organizations.

- XI. To render free advice and consultancy for the use of organic manure, herbal pesticides, vermicompost for Agricultural development , Micro Finance (To accept loan from any Banking & Non-Banking Financial Institutions and to disburse loan among the members of SHGs belong to economically backward classes of people of our locality), Animal Husbandry, Dairy, Duckery, Goatery, Poultry etc. and to campaign health oriented programs like Blood donation, Eye Operation, Cancer, leprosy, HIV AIDS, Thalasamia, Japanese Encephalitis, Ebola etc. with the help of expert doctors.
- XII. To establish recreation centers, orphanage home for the destitute, Crèche and other related institutions to promote the objectives of the society and Basic School Education in Nursery, Secondary and Higher Secondary level etc. In such manner as the Committee may think fit including :-
- XIII. To establish and maintain old age homes, day care centers of all senior citizens irrespective of sex, castes, creed and colors including community health services of the aged keeping in view the prevention promotional and curative services complemented with health education.
- XIV. To render relief to the sufferers in time of famine, flood, drought, earthquake and other natural calamities.
- XV. To educate the people about pollution and arrange plantation of trees in the locality to make the world green and to create clean environment and to prevent the destruction of river banks and conservation of water resources.
- XVI. To establish an interdisciplinary body for giving effect to available technical knowledge on water supply , sanitation, low cost housing, production of Bio-gas energy, domestic use of solar energy, utilization and development of fisheries, animal husbandry and agriculture as an integrated part of each development program.

- XVII. To open, found, establish, promote, set up, maintain, assist, finance support and /or aid or help in the setting up and /or maintaining and /or running schools, colleges, lecture halls and other establishments or institutions for advancement of education and of knowledge in Arts, Commerce, Science, literature , Humanities and all other useful subjects in all their manifestation.
- XVIII. To grant pay or give scholarship stipends, prizes, rewards, awards, allowances and other financial assistances or help in cash or kind to students with a view to help them in prosecuting their studies in schools, colleges, educational institutions, technical institutions, art schools, institution teaching commercial and other arts including teaching of culture arts of other training research or educational works in India or abroad.
- XIX. The trustees may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties or in such manner as allowed by law as may be in force from time to time and to convert, alter very dispose of or transfer such investments shall not be made which are directly or indirectly for the benefit of any person referred to in Sub Sec. (3) of Sec. 13 of the Income Tax Act, 1961 or any subsequent amendments as may be made from time to time.
- XX. To arrange Awareness Generation Program among the local people regarding the Child Trafficking, Women Trafficking, Human Trafficking and assist with the local administration in collaboration with appropriate authorities.
- XXI. To arrange Awareness Generation Program among the local people regarding the Female Feticide with the help of expert doctors and assist with the local administration in collaboration with appropriate authorities.
- XXII. To set up park and garden for the development of mental health of the children as well as students and older.
- XXIII. To encourage horticulture and floriculture and arrange training with the help of expert teachers.
- XXIV. To encourage and motivate the local cultivators towards the scientific cultivation through the use of organic manure and herbal pesticides with modern irrigation system.

- XXV. To alleviate the sufferings domestic, non-domestic and wild animals, birds, insects and provide proper treatment with the help of expert doctors.
- XXVI. To undertake skill development and capacity building program among the educated young boys and girls.
- XXVII. To arrange computer literacy Training Center for the rural people as well as students with the help of expert computer teachers and after completion of the said training the Trust authority may issue certificate in favor of them.
- XXVIII. To co-operate with State, National or International Organizations having similar objects.
- XXIX. To arrange Awareness Generation Program among the local people combating the desertification, degradation of land & drought with the help of expert teachers and assist with the local administration in collaboration with appropriate authorities.
- XXX. To take necessary steps and actions to save mankind and all creatures with the proper permission of the appropriate authorities.
- XXXI. To disburse loan among the people live below the poverty line and economically backward classes of people to ameliorate their distressed condition and to assist them to tide over their destiny of misfortune as suffered by them.
- XXXII. To aware the common people regarding the unscientific and age-old superstitions that are primarily responsible for their lots. The program is desired to educate them to lead the better subsistence of life progressively.
- XXXIII. To assist cultivators, micro-businessmen to promote, formation, mobilization, capacity building and skill development training includes micro financing.
- XXXIV. To render financial assistance to any educational, health centers and other charitable organizations having such objects without profit motives.
- XXXV. To assist & arrange Micro-Insurance for the SHGs Members, micro-businessmen with the help of appropriate authority and necessary permission.
- XXXVI. To empower and ensure the SHGs members through micro-credit programme so that they able to continue their activities without any economic support in the long run.
- XXXVII. To arrange and organize Awareness Generation Program to protect Human Right in everywhere in the country with the help of expert teachers and lawyers with the help of appropriate authority.



RULES AND REGULATIONS

(Trust Registration Act, 1881)

1. DEFINATION:

In this rule and regulations unless the content otherwise requires, words and expression have the following meanings.

- a. "TRUST" means the trust established under Registration of Trust Act, 1882 as per the Memorandum of Trust.
- b. The Trust Board means the Trust board of the Trust constituted as provided there rules and regulations.
- c. Special Resolution means a resolution passed by majority of not less than two third of the members of the Trust present in person, at a General Body meeting called for the purpose.

2. TRUST BOARD:

The total of trustees including the first Trustee should be limited to three only. However all the trustees unless they voluntarily resign or otherwise decide shall continue to be the trustees during the term of their natural lives. Any trustees may retire at any time without assigning reason and without being responsible for any cost occasioned by such retirement.

Any member or members may be authorized by the Trust Board to perform any special duty entrusted to them. To make it broader based effective, one or two eminent of public importance members may be co-opted by the Trust Board unanimously. The terms of the members shall be two years and one may be elected not more than two terms consecutively.

An appointed member may retire from office on giving notice in writing to the Trust Board. If an appointed member ceases to hold office for any reason whatsoever, at any time the Board may appoint any other member to hold office in his place for the rest of the term. The Trust Board shall have full power to act notwithstanding any vacancy that may not have been filled up.

3. HONORARY:

Trust Board may constitute at any time an Advisory Board to aid advice the Trust Board on matters concerning the interests of the Trust. But such honorary members shall have no right to vote.

4. REMOVAL OF MEMBERSHIP FROM THE TRUST BOARD:

The membership under the following conditions from Trust Board shall be removed.

- a) If he/she does not attend three consecutive meetings regularly without informing reasonable inability.
- b) If he/she is found to be guilty by any Criminal Court or suffers from mental disease.
- c) If his/her character is found harmful to the interest of the Trust.
- d) If he/she does not follow the rules and regulations of the Trust.
- e) If a member tender his/her resignation in writing to the Trust Board of the Trust.

5. POWER OF THE TRUST BOARD:

The Trust Board shall have full power to do all such acts or things as may be necessary to carry out the objects of the trust and for the management of all its affairs or which in its opinion advance the objects of the Trust, in particulars, the said Trust Board is authorized to do among others the following acts and things:-

- a) The Management and Administration of the trust shall be vested in the Board of trustees.
- b) Subjects to the restrictions contained in this rules to dispose of the funds of the Trust for the purposes of the Trust.



- c) To manage and superintend the affairs of the Trust and to exercise all such powers of the Trust as are not under the statutes of this regulations required to be exercised by the Trust in the Trust Board Meeting .
- d) To conduct their own meetings and to regulate their own proceedings and to fix the dates for all general body meetings for the Trust.
- e) To appoint/terminate professional, technical, practical, commercial personnel or advisors or any other personnel or such purposes as shall be beneficial to the trust.
- f) To establish such committees as it considers necessary or desirable to assist it in carry out its responsibilities and to delegate to such committees necessary powers and authority.
- g) To take responsibility over the affairs and activities of the Trust and to lay down general policy or its behalf.
- h) To establish and abolish various administrative posts and offices and fix duties and terms of employment related to them to engage suitable personal exercise control and deal with administrative contingencies obligations and supervision.
- i) To establish procedure for selecting and supervising projects of the Trust.
- j) To delegate to the Managing Trust such power and responsibilities as is considers to be expedient.



- k) To draw up and present to all members and Annual Report on the Trust activities, income and expenditure and an externally audited statement of accounts.
- l) To open and operate on savings /current /fixed deposits or any other accounts and overdrafts with Bank or Banks investment companies in the name of the Trust or in any other name upon such terms and in such manner as the Trust Board shall deem fit and to appoint or to remove those who operate on such accounts.
- m) To commence prosecute defend or appear in continue comprise, abandon content or submit to any criminal civil administrative revenue, municipality, arbitration, conciliation or other proceedings or inquiry for the furtherance of or in conjunction with any objects of Trust and to appoint retain agents; attorney, advocates or solicitors therefore.
- n) The Trust Board may confer Managing trustee or any other trustees / person(s) power to do all or any of the following matters or things that is to say to present for registration admit the execution of and take back from any registration office in India, any documents of whatsoever nature which shall have been executed by the Trust.
- o) The Board of trustees shall have the power to acquire immovable or movable properties for the trust and like wise the power to sell, lease or mortgage or otherwise deal with such properties.



- p) The Managing Trustees shall hold office for life or until he/she resigns there from or till relived from such office by the Board by majority of trust board members.

6. MEETINGS OF THE TRUST BOARD:

- a) The Trust Board shall meet at least once in every six months at such places and times as they may from time to time determine.
- b) A meeting of the Trust Board may at any time be called by the Managing Trustee by giving at least seven days clear notice.
- c) The Managing Trustee shall call a meeting of the Trust Board on the written request of three or more members of the Trust Board.
- d) All meetings of the Trust Board shall be presided over by the Managing Trustee.
- e) All questions shall be decided by a simple majority of the vote of those present and the Managing Trustee in case of tie of votes shall have an additional or casting vote.
- f) An emergency meeting can be called by the Managing Trustees by giving at least 24 hours notice.

7. QUORUM:

- a) The quorum necessary for meetings of the Trust Board shall be at least two third of the total members of the Trust Board.

- b) A resolution of a proposal circulated by Managing Trustee of the Trust Board and approved and signed by the majority of members shall be valid and binding as if the resolution had been passed at a meeting of the Trust Board duly convened. Such decisions shall thereafter be confirmed in the next Trust Board meeting.
- c) A new copy of amendment will be obtained from the registering office and shall be kept on record for the Trust.

8. GENERAL BODY MEETING:

- a) The Trust shall in each year call a general meeting of all its members and its annual general body meeting in addition to any other meetings held in that year. The annual general body meeting shall be convened for the following purpose by the Managing Trustee.
 - i) To receive the annual report of the Trust Board.
 - ii) To receive and approve the accounts budget of the Trust Board.
 - iii) To appoint the auditors of the Trust.
- b) The quorum of the general body meeting shall be 50% of the member of the Trust.
- c) All questions at any Trust Board meeting shall be decided by a simple majority of votes, if equal the presiding Managing Trustee shall have an additional casting vote.
- d) At any Trust Board meeting every one shall cast one vote each.

9. ACCOUNTS:

- a) The settler and Managing Trustee and any of the Trustee (nominated by Board) shall jointly operated the Bank Account/Accounts of the Trust. The funds of the Trust Board shall be deposited in a Bank in the name of the Trust and all cheques and other transactions issued thereto shall be signed by the authorized signatories.
- b) The property and income of the Trust shall be applied solely towards the promotion of the objects of the Trust Board as set forth in the memorandum of the Trust.
- c) The Trust fund may accumulated by the income from the initial fund and also to raise or acquire funds of property from Central/State Government , Foreign Agencies, Non Government Agencies, Charitable Trusts by way of donations or grants or contribution or by taking loan from public and private financial institutions . The surplus and un-applied portion of the said income if any arising in any one or more year or years shall be accumulate and /or invested in accordance with the provisions of the Income Tax Act. 1961 as may be applicable from time to time.
- d) Without prejudice to the generality of the provisions contained about the Board of trustees may also empower the managing trustee to represent or act for the Trust in any matter the properties, funds, investments, borrowings and the making or cancellation of any instruments for any of the purpose.

10. AUDIT:

- a) The accounts of the Trust Board shall be audited by qualified Auditor/Auditors/Chartered Accountant shall be appointed as per the direction of the Trust Board and their duties regulated in accordance with the requirements of the Trust as determined by the Trust Board.
- b) The financial year of the Trust shall be from 1st April to 31st March of the next year.
- c) At least once in every year the accounts of the Trust shall be examined by Auditor / Auditors/Chartered Accountant.

11. FOUNDER MEMBER:

- a) The settler of MANAGING TRUSTEE AMAR CHANDRA BISWAS, DEBI BISWAS, AND PAPAI BISWAS shall be the life member of the Trust Board.
- b) The Managing Trustee during his/her life time shall name a successor to the office of Managing trustee and on his failure to do so the successor may be appointed by the Board of Trust on such terms and conditions as the Managing Trustee or be the Board of Trust deem fit and proper.

12. AMENDMENT:

No amendments to the trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time .

13. DISSOLUTION:

In the event of dissolution of winding up of the Trust the assets of the Trust remaining on the date of dissolution shall under the circumstance be distributed among the trustees , but the same shall transferred to other Trust, Societies, Association or Institution whose objects are similar to those of this Trust.

14. LEGAL ACTION:

All legal proceedings by or against the Trust shall be instituted in the name of trust through its Managing Trustee(s) / director(s) / Legal Solicitor appointed by the Trust Board who will also present the trust in respect of any proceeding and before any Government and / or non-government authority.

15. INTERPRETATION OF RULES :

In case of conflict arising out of the reading of the memorandum and the rules and regulations of the trust the interpretation given by the Trust Board shall be final.
